We are unable to accept the contention made on behalf of the applicant as we are not in a position to go into the legality and validity of the order passed by the contemnor by rejecting the prayer of the applicant for compassionate appointment, when the specific direction of the Tribunal was to take a decision in connection with the application for compassionate
