The Respondent No. 1, Principal Secretary to the Government of West Bengal, Department of Women and Child Development and Social Welfare is directed to reconsider the entitlement of the applicant to get pre-revised scale no. 19 at par with the Medical Officer of West Bengal Health Service in terms of Memorandum No. 10581-F(P) dated December 28, 2012 issued by the Finance Department, Audit Branch, Government of West Bengal by passing a reasoned order after obtaining necessary approval from the Finance Department, Government of West Bengal, if necessary, within a period of 12 (twelve) weeks from the date of communication of the order and take necessary follow-up action within a period of 08 (eight) weeks thereafter.</b></p>
