favour of the applicant Shibani Pal and for disbursement of balance amount of General Provident Fund, Life Time Arrears of pension, amount of Gratuity, amount of Leave Encashment and amount of Group Insurance, if not already released.

The compliance report submitted by the contemnor on December 18, 2018 clearly indicates that family pension was sanctioned in favour of the applicant Shibani *Pal.* The said compliance report has further pointed out that the contemnor has already issued order for release of balance amount of General Provident Fund, Life Time Arrears of pension, Gratuity, Leave salary and the amount of Group Insurance. The applicants have also disclosed in the affidavit filed before the Bench on February 08, 2019 that they have received the amount of Group Insurance, amount of General Provident Fund, amount of Leave Salary, Life Time Arrears of Pension and the retiring gratuity. The report submitted by the contemnor, A.G., W.B. has specifically pointed out that PPO for family pension of Shibani Pal was issued on March 24, 2017. The said report further indicates that Life Time Arrears of pension @ Rs. 1,060/- p.m. has been sanctioned during the period from August 22, 1993 till July 05, 2013 i.e. the date of death of the concerned employee. > Arrears of pension has already been sanctioned w.e.f. May 22, 1993. The prayer of the applicants with regard to non-compliance of the order of the Tribunal by the contemnors with regard to non-payment of life time arrears of pension and arrears of salary of the deceased employee for 19 months and revision of family pension are beyond the scope and ambit of the contempt application, as the applicants are not entitled to the said relief in terms of the original order passed by the Tribunal for whose violation the contempt application has been filed.

In view of our above observation, we are constrained to hold that the contemnors have complied with the direction given by this Tribunal. Accordingly, the contempt application stands disposed of.
