"Accordingly, the Tribunal feels that the Application should now be disposed of with a direction upon the Director of Personnel & Ex-Officio Chief Engineer, Irrigation & Waterways Directorate to publish the result of the Interview held by the Selection Committee and clarify as to whether notwithstanding availability of eligible candidates from the exempted category such vacancy was filled up by the General Category. The Director of Personnel & Ex-Officio Chief Engineer, Irrigation & Waterways Directorate will comply with the Order of this Tribunal within a period of 6 (six) weeks from the date of receipt of this Order."

The statement of compliance of the order submitted by the contemnor on September 12, 2017 is enclosed with the contempt application, wherefrom it appears that the recruitment process to fill up posts of 1409 vacancies under Group-D category was initiated only for non-exempted category. Accordingly, the contemnor was not in a position to publish the list of candidates selected from exempted category to fill up the Group-D posts as directed by the Tribunal. However, the fact that entire recruitment process was initiated to fill up Group-D posts only from non-
