He further submits that copy of the observations of the Finance Department has already been forwarded to the Principal of the Institute of P.G. Ayurved Education and Research and the Superintendent of Viswanath Ayurved Mahavidyalaya and Hospital for the purpose of grant of benefit of scale and other financial benefits to the applicants (six in numbers). Mr. Bera, Learned Counsel representing the applicants submits that the Tribunal gave direction for issuance of order by giving benefit of scale in favour of the applicants. He further submits that the order should have been issued by the Director of Health Services, Government of West Bengal in terms of the observations made by the Finance Department, Government of West Bengal.</p>
