	Mr. D.N. Ray, Learned Counsel appearing for the applicants contends that one Swarnamoyee Dutta and	

others approached the Tribunal for getting the benefit of Supernumerary post but failed to obtain favourable order from the Tribunal. The order of the Tribunal was challenged before the Hon'ble High Court by filing W.P.S.T. No. 190 of 2014. Since the applicant Nikhil Krishna Dutta and others were impleaded as party in the original application filed by Swarnamoyee Dutta before the Tribunal, they approached the Hon'ble High Court for being impleaded as party in W.P.S.T. No. 190 of 2014 by filing CAN No. 7729 of 2014. Mr. Ray submits that the issues involved in the present applications will be decided by the Hon'ble High Court in W.P.S.T. No. 190 of 2014 and as such the Tribunal should wait for hearing of the original applications till the hearing and disposal of W.P.S.T. No. 190 of 2014. He further submits that the interim stay is also granted by Hon'ble High Court in this regard.

We have heard Mr. A.L. Basu, Learned Counsel representing the state respondents.

It appears from the materials on record that on August 27, 2014, the Division Bench of the Hon'ble High Court granted interim stay of operation of the
