	The applicant has prayed for direction upon the		
	respondents to appoint the applicant in the post of		
	Head Clerk (Supervisor) after quashing of order dated		
	July 19, 2016 issued by the Director of Animal		
	Husbandry and Veterinary Services, Government of		
	West Bengal in OA-939/2016. The applicant has		
	subsequently prayed for quashing of order dated		
	November 10, 2016 issued by the Director of Animal		
	Husbandry and Veterinary Services, Government of		
	West Bengal in MA-187/2016. The applicant has		
	also prayed for quashing of Memorandum dated		
	June 19, 2017 issued by the Director of Animal		
	Husbandry and Veterinary Services, Government of		
	West Bengal in MA-79/2017. Issues involved in the		
	original application and both the miscellaneous		
	applications are connected and as such all the		
	applications are taken up together for hearing and		
	disposal by this common order.		
	The applicant joined in Group 'D' post in the		
	Directorate of Animal Husbandry and Veterinary		
	Services, Government of West Bengal on May 04,

	1976. He got promotion to the post of Lower Division	
	Clerk in the Directorate on January 16, 1992 subject	
	to the condition that he will be reverted to the	
	substantive post of Group 'D' in the Directorate in the	
	event one Ramendra Nath Halder, Ex-Lower Division	
	Clerk holding lien in the said service joins back to the	
	Directorate. He also got promotion to the Upper	
	Division Clerk w.e.f. August 01, 2002. The applicant	
	was aspiring to get promotion to the post of Head	
	Clerk (Supervisor) in the Directorate, but the same	
	was not considered by the concerned authority. The	
	applicant approached the Tribunal by filing OA-	
	162/2015 which was disposed of on February 24,	
	2016. The Tribunal directed the Director of Animal	
	Husbandry and Veterinary Services, Government of	
	West Bengal to take a decision on the issue of	
	promotion of the applicant on the basis of his	
	representation after giving the applicant an	
	opportunity of hearing. On July 19, 2016 the Director	
	of Animal Husbandry and Veterinary Services,	
	Government of West Bengal passed a reasoned order	
	denying the claim of the applicant for being	
	considered for promotion to the post of Head Clerk	
	(Supervisor) in the Directorate on the ground that	
	upward movement of the applicant from the post of	
	Peon to the post of Lower Division Clerk and

	subsequently to the post of Upper Division Clerk was	
	not done in a regular manner. The reasoned order	
	indicates that regularisation of the promotion of the	
	applicant and the seniority of the applicant will be	
	refixed in accordance with rules applicable to the	
	employees of the Directorate in due course. The	
	applicant challenged the said reasoned order dated	
	July 19, 2016 in the original application.	
	During pendency of the original application the	
	Director of Animal Husbandry and Veterinary	
	Services, Government of West Bengal issued order	
	dated November 10, 2016 by setting aside the	
	irregular order of promotion of the applicant after long	
	lapse of time. In view of joining back of Ramendra	
	Nath Halder in the service of the Directorate, the	
	irregular promotion granted to the applicant was	
	rectified by the Director of Animal Husbandry and	
	Veterinary Services by issuing order dated March 27,	
	2017 and order dated June 19, 2017. Ultimately, the	
	applicant got promotion to the post of Lower Division	
	Clerk w.e.f. February 01, 1997 and promotion to the	
	post of Upper Division Clerk w.e.f. March 24, 2005.	
	The applicant retired from service on February 28,	
	2018.	
	With the above factual matrix, Learned Counsel	

for the applicant contends that the applicant cannot

	be reverted to the substantive post of Group 'D' in the	
	Directorate after long lapse of 14 (fourteen) years. He	
	also submits that the salary drawn by the applicant	
	for discharging his duty as Lower Division Clerk and	
	as Upper Division Clerk cannot be recovered from him	
	as directed by order dated March 27, 2017. He also	
	submits that the retiral benefits of the applicant	
	should be given w.e.f. the date of his previous	
	promotion to Upper Division Clerk on August 01,	
	2002. On the other hand, Learned Counsel	
	representing the state respondents submits that the	
	previous promotion granted to the applicant was a	
	mistake and the applicant was well aware of the fact	
	of getting promotion on condition of reversion to the	
	substantive post in the event Ramendra Nath Halder	
	joins back in the service of the Directorate for holding	
	lien in the said service.	
	Having heard Learned Counsel representing	
	both parties and on consideration of the background	
	of passing order of recovery of the overdrawal	
	amount of the applicant, we find that the applicant	
	had no role to play in getting previous promotion from	
	the post of Group 'D' to Lower Division Clerk and	
	thereafter promotion from Lower Division Clerk to	
	Upper Division Clerk. We are not oblivious of the fact	
	that irregularity committed by the administration in

	granting further promotion to the applicant from the	
	post of Lower Division Clerk to the post of Upper	
	Division Clerk needs to be rectified, as no right can	
	accrue on the basis of a mistake committed by the	
	administration. However, the applicant has drawn	
	the salary of Lower Division Clerk and salary of	
	Upper Division Clerk in discharging his duty in those	
	posts without having any role to play in the	
	promotion and as such the salary which has been	
	drawn by the applicant cannot be considered as	
	overdrawal. The question of recovery of the amount of	
	salary drawn by the applicant for discharging his	
	duty in the post of Lower Division Clerk and in the	
	post of Upper Division Clerk cannot be recovered as	
	ordered by the Director in the impugned order dated	
	March 27, 2017 and order dated June 19, 2017.	
	Since the applicant is not entitled to get any benefit	
	for previous irregular promotion, we are of the view	
	that the applicant is entitled to get Pension, Gratuity	
	and other retiral benefits of service in terms of	
	promotion to the post of Upper Division Clerk in the	
	Directorate w.e.f. March 24, 2005 as reflected in the	
	order dated June 19, 2017.	
	It is pertinent to point out that the Learned	
	Counsel for the applicant has not pressed for the	
	prayer for promotion to the post of Head Clerk

	In view of our above observation, we cannot		
	persuade ourselves to quash the order dated July 19,		
	2016, order dated November 10, 2016, order dated		
	March 27, 2017 and order dated June 19, 2017		
	passed by the Director of Animal Husbandry and		
	Veterinary Services, Government of West Bengal,		
	except the order of recovery of overdrawal mentioned		
	in the order dated June 19, 2017 and order dated		
	March 27, 2017 passed by the Director of Animal		
	Husbandry and Veterinary Services, Government of		
	West Bengal. Accordingly, the Director of Animal		
	Husbandry and Veterinary Services, Government of		
	West Bengal is prohibited from recovering any		
	amount of overdrawal from the applicant in terms of		
	the orders passed by him on March 27, 2017 and		
	June 19, 2017. With the above direction, the original		
	application stands <b>disposed of.</b>

	both parties.
