	approached this Tribunal almost 10(ten) years	
	without any valid reason.	
	Heard both the parties and perused the	
	records. During the course of hearing the	
	Counsel for the applicant has referred one	
	judgement passed by the Hon'ble High Court in	
	W.P.C.T. No. 275 of 2012 dated 17-01-2013. It	
	is noted that Ex-employee died on 26-11-2008	
	leaving behind his widow and 5(five) sons and	
	one daughter, all the sons were major at the	
	point of time. However the elder brother and	
	mother have given no objection. The instant	
	application has been filed even after 9(nine)	
	years from the date of submission of the	
	representation though according to the	
	applicant that they have waited for the	
	proforma application but till date no proforma	
	application has been filed and they are praying	
	for condonation of delay on this ground.	
	However in our considered opinion, it is

	overcome the sudden financial crisis cause due	
	to sudden demise of the sole bread earner. As	
	the applicant had waited for long 10(ten) years	
	from the date of death of his father, therefore in	
	our considered view, the main purpose of	
	compassionate appointment has been	
	frustrated and we do not find any reason to	
	condon the delay as there is no sufficient	
	ground for waiting for a long time rather the	
	applicant could have approached this Tribunal	
	after reasonable time if there is any non-action	
	on the part of the respondent. However with	
	regard to the aforementioned judgement, the	
	case of Monosakha Manna & Another Vs. Union	
	of India & Others, it is observed that the fact of	
	the case rather quite distinguishable as some	
	progress has occurred with regard to the case	
	of the applicant of the aforesaid matter in the	
	year of 2000. Subsequently no final decision	
	was communicated to the applicant in the said	
	application.	
	However the order of the Tribunal was	
	also not rejected by the Hon'ble High Court.
