order dated December 09, 2014 passed in connection with OA 637 of 2014. It appears from the said orders that the applicant was directed to file application for grant of leave in terms of the service rules by which he is governed for the purpose of regularisation of his absence from duty, but the copy of such leave applications is not forthcoming before the Tribunal in the present case.

Under the above circumstances, we direct the applicant to file supplementary application disclosing copy of previous leave application filed by the applicant for regularisation of his absence from duty in terms of the direction given by the Tribunal in OA 637 of 2014 on the next date of hearing. The applicant is also directed to disclose the copy of the orders passed by this Tribunal in previous applicants moved by him before the Tribunal by way of supplementary application on the next date of hearing.
