On consideration of the fact that the persons who are junior to the applicant are getting higher scale of pay having the qualification of the applicant for not including the post of the applicant either in West Bengal Ayurvedic Education Service or West Bengal Ayurvedic Health Service, we are of the view that the applicant is at liberty to submit appropriate representation before the respondent no.1 by ventilating his grievances within specific period of time and the same will be considered by the concerned respondent within specific period of time.
