Banerjee, Learned Advocate.</p> <p>The instant application has been filed praying for release of 70 % of pension as the applicant has already been punished with 10 % cut in pension in each case of three different disciplinary proceedings i.e. total 30 % cut in pension. However, during the course of hearing, counsel for the applicant has submitted that the respondents were yet to take decision to initiate another departmental proceeding under Rule 10.</p> <p>However, the counsel for the respondent, on instruction, has submitted that another departmental proceeding has already been initiated thereafter vide proceeding No. 7/18 dated 21.05.2018 wherein the applicant has already been participated as per Rule 10. Therefore, unless the said proceedings would be completed, the applicant cannot be granted 70 % of pension.</p>
