The applicants have prayed for direction upon the respondents for payment of enhanced remuneration @ ₹ 2,000/- p.m. w.e.f. June 01, 2009 and other consequential reliefs.

The contention of the applicants is that they were engaged as Sweeper-cum-Water Carrier in the office of the Revenue Inspector of Sitai Block on the basis of order dated October 28, 1989 issued by the Sub-Divisional Land & Land Reforms Officer, Dinhata, Coochbehar. The further contention of the applicants is that they have not been given arrears of enhanced remuneration in terms of the government orders issued by the Finance Department, Government of West Bengal. All the applicants submitted representation before the respondents including the respondent no. 3, District Land & Land Reforms Officer, Coochbehar on November 14, 2017, but the same has not been disposed of till date.
