Mr. Ali, Learned Senior Counsel representing the applicants has seriously disputed the submission made on behalf of the state respondents. According to Mr. Ali, the applicants are totally in the dark whether the defects in the application have been removed by the state respondents within the stipulated period of time and whether the matter was mentioned before the Hon'ble Chief Justice on December 14, 2018.

Having heard Learned Counsel representing both parties, we find that the Division Bench of the Hon'ble High Court has come to know about both the Review Application and CAN filed by the State Respondents, though in defective form.
