	There is no dispute that Bandita Mahata, the		
	applicant is the grand-daughter of late Falari Mahato,		
	who had lost his land in the year 1968. Under Notification		
	date 21 st August, 2008 one member from an uprooted		
	affected family shall be eligible for consideration against		
	vacancies to be reserved for the exempted categories.		
	This is applicable in respect of cases where land was		
	acquired by the State on or after 17 th October, 1977. In		
	the instant case, there is no dispute that the acquisition		
	took place in the year 1968 that is much before 17 th		
	October, 1977. Hence, under the said notification the		
	applicant is not entitled for employment against the		
	vacancies under the exempted category.		
	Under the Gazette notification dated 5 th		
	January, 2005 issued by the Labour Department, the		
	family will be regarded as land loser if it comprises of		
	following members :-		
	"1. Land loser himself/herself.		
	2. Wife/Husband of land loser.
