Bench of the Hon'ble High Court, we find that the case in connection with which SLP is pending before the Hon'ble Supreme Court relates to promotion from the post of Junior Lecturer to the post of Lecturer in Government Sponsored Polytechnic, whereas in the instant case, the applicant has prayed for promotion from the post of Junior Lecturer to the post of Lecturer in Government Polytechnic in terms of some transitory provision made by way of amendment in the relevant recruitment rules.
