During the course of hearing the counsel for the applicant has submitted that though after provisionally selected by the authority, the applicant was directed to appear before the competent authority in connection with the appointment and training by way of verification of documents and on the next date i.e. on 03.12.2007, on the suspicion of impersonation, he was arrested and one criminal case was filed against him, therefore, he could not join the training. However, the said criminal case being No. GR 2063 of 2007 was finally disposed of vide judgement dated 09.04.2013 and the applicant was discharged under Section 239 of Code of Criminal Procedure by way of exoneration. Subsequently, he made a representation before the S.P. Nadia on 25.07.2013 praying for allowing him to join the training in the said post. However, till date no response has been received by</p>
