Having heard Learned Counsel representing both parties and on consideration of the materials on record, we are of the view that the representation of the applicant should be taken into consideration in accordance with the provisions of law within a reasonable period of time. However, the present representation submitted by the applicant before the Superintending Engineer through proper channel cannot be considered by the Chief Engineer (Headquarters), PW (Roads) Directorate who has published previous gradation list on November 3, 2016. We would like to grant liberty to the applicant to file representation before the Chief Engineer (Headquarters) through proper channel within a reasonable period of time.

Accordingly, the applicant is directed to submit representation ventilating his grievance with regard to non-inclusion of his name in the gradation list of regular Group-D and Group-C employees of Public Works (Roads) Directorate before the respondent no. 3, Chief Engineer (Headquarters), PW (Roads) Directorate through proper channel within a period of 8 (eight) weeks from the date of this order. If such representation is submitted by the applicant within the stipulated period of time the respondent no. 3, Chief Engineer (Headquarters), PW (Roads) Directorate, Government of West Bengal is directed to consider the representation of the applicant in accordance with law within a period of 12 (twelve) weeks from the date of submission of the representation and communicate the result of
