The applicants have prayed for direction upon the respondents for giving benefit of past service as Khalasi and not to deduct any amount from retirement benefits on the ground of overdrawal of salary.

The contention of the applicants is that they were appointed initially on temporary basis in the regular establishment as Khalasi w.e.f. 01.04.1996 and got the retirement benefits including Gratuity and Pension. The further contention of the applicants is that the respondents have issued letters calling upon the Executive Engineer, Mayurakshi South Canal Division for deduction of amount overdrawn by each of the applicants from the retirement benefits. There is nothing on record to indicate that any specific amount of money is deducted from the retirement benefits of the applicants on the ground of overdrawal of salary. In the absence of any document to indicate that State Respondents have deducted any amount of money from
