contends that the applicant will not be governed by Memorandum No. 2966-F(P) dated April 23 and other subsequent Memorandums issued in this regard by the Finance Department, Audit Branch, Government of West Bengal as the applicant has been discharging the duty as part time employee in the establishment of respondent no. 5.

Having heard Learned Counsel representing both parties and on consideration of the materials on record, we find that the applicant has been receiving monthly remuneration @ Rs. 2,000/- p.m. which unerringly points out that the applicant is a part time casual employee in the establishment of the respondent no. 5. Since the applicant has been discharging the duty as part time casual employee, he is entitled to get enhanced remuneration @ Rs. 3,000/- p.m. w.e.f. January 01, 2018 in terms of Memorandum No. 7284-F(P2)/FA/O/2M/1dated November 27, 2017 issued by the Finance Department, Audit Branch, Government of West Bengal. The applicant is not entitled to get financial benefit in terms of G.O No.2966-F(P) dated April 23, 2010 and all other subsequent GOs issued by the Finance Department, Government of West Bengal for full time casual, daily rated and contractual employees.

ORDER SHEET Partha Chandra Form No. Vs. The State of West Bengal & Ors. Case No. OA 184 OF 2019 In view of our above observation, we direct the respondent no. 5, Sub-Divisional Controller, Food & Supplies, Suri to pay the applicant enhanced remuneration @ 3,000/- p.m. w.e.f. January 01, 2018 in terms of Memorandum No. 7284-F(P2)/FA/O/2M/1 dated November 27, 2017 issued by the Finance Department, Audit Branch, Government of West Bengal within a period of 12(twelve) weeks from the date of communication of the order.
