	The contention of the applicant is that the applicant got promotion to the post of Zilladar on the basis of order dated October 04, 2016 issued by the Director of Personnel and Ex-Officio Chief Engineer, Irrigation and Waterways Directorate, Government of West Bengal and drawing salary in Pay Band No. 2 with Grade Pay of ₹ 2,900/- w.e.f. January 01, 2016. The further contention of the applicant is that some of his colleagues holding the post of Zilladar got higher un-revised scale no. 9 in terms of the order issued by the Secretary to the Government of West Bengal, Department of Irrigation and Waterways in compliance with the direction given by the Tribunal in OA-4802/2008. November 27, 2018 (annexure 'E' to the original application) praying for grant of higher Pay Band No. 3 with Grade Pay of ₹ 3,600/- plus allowances admissible to him under the rules with effect from the date of his joining as Zilladar, but the said representation is pending for consideration till date.

Having heard Learned Counsel representing both parties and on consideration of the materials on record, we find that the respondent no. 3 previously issued one reasoned order on August 11, 2009 for granting higher scale of pay to some of the Zilladars who moved the Tribunal by filing OA-4802/2008 (Biplab Kumar Sikder & Ors. V The State of West Bengal & Ors.) but the said order was passed for grant of un-revised scale no. 9 to some of the Zilladars as there was anomaly in granting scale of pay to the Zilladars at the relevant point of time in terms of ROPA Rules, 1981, ROPA Rules, 1990 and ROPA Rules, 1998. In the present case, the applicant has been drawing salary after promotion in Pay Band No. terms of ROPA Rules, 2009. representation submitted by the applicant before the respondent no. 3 for stepping up of salary of the applicant by grant of Pay Band No. 3 has not yet been considered and since the decision in this regard can
