During the course of hearing, the Council for the applicant has submitted that he was not allowed to join his duty after being arrested as he was in custody beyond 48 hours - but no formal suspension order was issued. Therefore, he made representation before the Authority, i.e., the Director General, West Bengal Fire and Emergency Services (Annexure-E) to allow him to resume duty as in the mean time, he was granted bail by the Hon'ble High Court and was released from the jail custody on 19.02.2020.

As no response was received by the instant applicant till 18th March, 2020 the copy of the application duly served upon the respondents dated 19.03.2020. However, vide E.O. No.278/2020, dated 26.06.2020, he was put under suspension with effect from 21.01.2020 (Annexure to supplementary affidavit). However, during the course of hearing, the Council for the applicant has submitted that he wants to make one comprehensive representation again before the Authority within 2(two) weeks and the Authority
