that he has not been paid remuneration in terms of memorandum no. 9008-F (P) dated September 16, 2011 and subsequent memorandums issued in this regard by the Finance Department, Audit Branch, Government of West Bengal.

Having heard Learned Counsel representing both parties and on consideration of the materials on record, we are not in a position to decide whether the applicant is entitled to get remuneration as part time causal employee in terms of memorandum dated November 27, 2017 or as full time casual employee in of memorandum no. 9008-F (P) September 16, 2011 and subsequent memorandums issued in this regard by the Finance Department, Audit Branch, Government of West Bengal. In the absence of sufficient materials before us, we are of the view that the respondent no. 1 should take a decision on verification of records whether the applicant is entitled to get remuneration as part time casual employee or as full time casual employee.

In view of our above observation, we direct the respondent no. 1, Principal Secretary to the Government of West Bengal, Department of Food and Supplies to consider whether the applicant is entitled
