	has been filed on behalf of the applicant.	
	Mr. K. Banerjee, learned advocate for the	
	applicant submits since the order dated 25 th July, 2014	
	dismissing the applicant was set aside by the appellate	
	authority, as evident from the order dated 27 th January,	
	2016 being annexure "A" to the application, and as it is	
	evident in page 3 of the status report prepared by the	
	State authorities, that the pay arrear, Gratuity,	
	commuted value of pension, cash equivalent of leave	
	salary and GPF final withdrawal were disbursed after	
	considerable delay and that too after filing of	
	representations, interest on delayed payment of the	
	amount, as prayed for, may be granted. Submission is the

	Mr. S.N. Ray, learned advocate for the State	
	respondent submits that the applicant is not entitled to	
	the interest in view of the notification as mentioned in	
	paragraph 5 of the Status report. Moreover, office does	
	not have the records regarding the deduction of Group	
	Insurance from the applicant.	
	In reply, it is submitted on behalf of the	
	applicant that as the order dismissing the applicant has	
	been set aside, he is entitled to get interest on the	
	delayed payment of the amount as mentioned in	
	paragraph 4 of the report. Moreover, as Group Insurance	
	was deducted regularly, the respondents are to pay the	
	same.	
	Having heard Mr. Banerjee and Mr. Ray and	
	considering the facts and circumstances of the case, since	
	we find that order of dismissal dated 25 th July, 2014	
	admittedly was set aside by the appellate authority and
