	13 of the reply it is "06.06.2018". Further, in 'e)	
	Experience' in page 36 of the original application does	
	not match with 'e) Experience' in page 13 of the reply.

Moreover the last page of the advertisement annexed to the application does not contain any date, though '28.05.2018' has been mentioned in the advertisement annexed to the reply. Moreover, we find there is a mismatch regarding closing date of the application. In the photocopy annexed in the original application it is "07.06.2018", whereas in the advertisement annexed at page 13 of the reply it is "06.06.2018". Mr. Halder, learned advocate for the applicant submits that his client, though entitled to, has not been awarded proper marks under the heading "Experience". As prima facie we find there is mismatch in the advertisement annexed to the original application and the reply filed by the State authorities, the Secretary, West Bengal Health Recruitment Board - Respondent no. 3 is directed to file a report regarding the same in a sealed cover before the Registrar, West Bengal Administrative Tribunal by 23 <sup>rd</sup> September, 2019.
