The applicant has prayed for direction upon the respondents for disbursement of arrears of remuneration from June 01, 2009 till February, 2013 in terms of Memorandum No. 8662-F dated September 07, 2009 issued by the Finance Department, Audit Branch, Government of West Bengal.

It appears from record that the Respondent No. 2 has passed an order on October 31, 2012 for payment of remuneration to the applicant as Part-time Sweeper @ Rs. 500/- per month w.e.f. June 01, 2009. The contention of the applicant is that arrears of remuneration during the period from June, 2009 to February, 2013 @ Rs. 500/- per month has not been disbursed in favour of the applicant till date. Under such circumstances, the Respondent No. 4, Block Youth Officer, Bhagwanpur-II is directed to disburse arrears of remuneration to the applicant during the period from June, 2009 to February, 2013 @ Rs. 500/- per month
