On query, he has further submitted that no review with regard to the suspension of the applicant from 2016 has been done so far. *However, he has prayed for further time to file reply.* However, during the course of hearing the counsel for the applicant has drawn our attention to the Memo dated 26.07.18 issued by the Deputy Secretary to the Government of West Bengal to the Director General of West Bengal Fire & Emergency Services, whereby the Government had directed to take necessary action for review of substantial question of suspension and payment of subsistence allowance with regard to the application. Even then till today neither review has been made with regard to the suspension nor any final order with regard to proceeding has departmental been passed. Therefore, he has prayed for interim order for quashing of the suspension order as it has not been reviewed by the respondents. *Heard the parties and perused the records.
