West Bengal vide Memo dated 10.08.2016. However, till date no communication has been made with regard to his compassionate appointment.

During the course of the hearing, the counsel for the applicant has fairly submitted that it would suffice the purpose of the applicant if the authority would be directed to take final decision and communicate the same by way of reasoned and speaking order within a stipulated period of time after granting him personal hearing as he is suffering financial crisis.

The counsel for the respondent has no objection.

In view of the above, respondent no. 3 is directed to take final decision with regard to the compassionate appointment of the applicant after granting him personal hearing by way of a reasoned and speaking order within a period of eight weeks from the date of receipt of the order. Accordingly, the O.A. is disposed of with no order as to cost.
