The petitioners have prayed for implementation of the Judgment and Order passed by this Tribunal on August 14, 2014 in OA-609 of 2012.

The contention of the petitioners is that the petitioners approached the Tribunal for fixation of additional remuneration for discharging additional and higher responsibilities as Tutor-Physiotherapist. By Judgment and Order dated August 14, 2014 passed in OA-609 of 2012 this Tribunal gave direction to the concerned respondents to determine the quantum of additional remuneration to be paid to the petitioners for discharging additional and higher responsibilities from the date of their assignment of the said responsibility, subject to the condition that the petitioners have necessary qualification to discharge their functions as Tutor-Physiotherapist within a period of 3 (three) months from the date of communication of the order.
