Engineer (Civil) in terms of order conveyed under letter dated October 13, 2008 issued by the Deputy Secretary, Public Works Department, Government of West Bengal. The applicant got promotion to the post of Executive Engineer in terms of Notification dated December 01, 2016 issued by the Joint Secretary (Personnel), Public Works Department, Government of West Bengal. The grievance of the applicant is that he was not given benefit of Career Advancement Scheme for completion of 16 years of satisfactory service.

Learned Counsel for the applicant submits that the applicant joined in the promotional post of Executive Engineer in the same scale of pay which was drawn by him in the feeder post of Assistant Engineer. Learned Counsel further submits that the representation submitted by the applicant is still pending for consideration of the Principal Secretary to the Government of West Bengal, Public Works Department.

None appears on behalf of the state respondents on call, inspite of service of notice as reflected from the affidavit of service filed on behalf of the applicant.

Having heard Learned Counsel for the applicant and on consideration of the materials on record, we are of the view that the respondent no. I should take a decision about the entitlement of the applicant to get the benefit of

Career Advancement Scheme for completion of 16 years of service on verification of record. Accordingly, the respondent no. 1, Principal Secretary to the Government of West Bengal, Public Works Department is directed to take a decision whether the applicant is entitled to get benefit of Career Advancement Scheme for completion of 16 years of service as Assistant Engineer and Executive Engineer after verification of records in accordance with law within a period of 12 weeks from the date of communication of the order and communicate the said decision to the applicant within a period of 8 weeks thereafter.
