	<p>that the Pension, the amount of G.P.F. and other retirement benefits have not been released in favour of the applicant inspite of acceptance of prayer for voluntary retirement about a year back.</p> <p>Having heard Learned Counsel representing both parties and on consideration of the materials on record, we are of the view that the applicant should furnish necessary information and submit all documents and fill up all necessary forms for release of retirement benefits and amount of G.P.F. within specific period of time. The respondents must release the retiral benefits and the amount of G.P.F. in favour of the applicant within specific period of time after acceptance of prayer of the applicant for voluntary retirement from government service.</p> <p>In view of our above findings, the applicant is directed to fill up necessary forms, furnish necessary information and submit necessary documents before the respondent No. 3 for release of Pension, Gratuity, Leave Encashment, if any, and the amount of G.P.F. and Group Insurance by the respondent no. 3, within a period of 04 (four) weeks from today.
