We are also in the dark about the previous order passed by the Tribunal and the order passed by the Hon'ble High Court and the Hon'ble Supreme Court.

Under the above circumstances, liberty is given to the applicant to file Supplementary Application praying for specific heads of retirement benefits of the applicant and enclose copy of previous order passed by the Tribunal and copy of the order passed by the Hon'ble High Court. The state respondents are directed to file specific reply about the heads of retirement benefits including Gratuity to which the applicant is entitled under the law before the next date of hearing.
