	respondents for grant of scale of pay in terms of West

1981 as amended by notification no. 9481-F dated September 03, 1984 issued by the Finance Department, Audit Branch, Government of West Bengal. The grievance of the applicant is that he has been deprived of scale of pay of which he was entitled in terms of notification dated September 03, 1984. Mr. Hati, Learned Counsel for the applicant contends that the applicant studied up to class XI at the time of entry into service as Pump Operator and as such he should be treated as a candidate who passed School Final Examination at the time of entry into service. The notification dated September 03, 1984 issued by the Finance Department, Audit Branch, Government of West Bengal indicates that the Assistant Pump Operator working in the Engineering Department and other offices of Government of West Bengal are entitled to get scale of pay of Rs. 300-685/- in terms of ROPA Rules, 1981 as amended by notification no. 9481-F dated September 03, 1984. None appears on behalf of the state respondents on call.

The issue for consideration of the Tribunal is whether the applicant is entitled to get scale of pay of Rs. 300-685/- on the ground of passing School Final Examination at the time of entry into service as Pump Operator. The system of passing School Final ORDER SHEET

Examination or Matriculation Examination was in vogue when the applicant was studied in the school. The entries made in the copy of the service book annexed to the original application indicate that the applicant studied up to class XI at the time of entry into service. Apparently, it appears that the applicant did not pass School Final Examination or Matriculation Examination at the time of entry into service, though he studied upto class XI as per school living certificate produced by him at the time of *entry into service. Since the applicant did not pass School* Final or Matriculation Examination, we cannot persuade ourselves to hold that the applicant is entitled to get the benefit of scale of pay of Assistant Pump Operator who passed School Final Examination at the time of entry into service. In our view the applicant is not entitled to get scale of pay of Rs. 280- 617/- which he enjoyed w.e.f. April 02, 1981. In view of our above findings, we cannot persuade ourselves to hold that the applicant is entitled to get scale of pay of Rs. 300-685/- as prayed for. As a result, the original application is dismissed.
