applicant was not engaged for any particular project. The reasons assigned by the respondent no. 2 for turning down the for prayer of the applicant are not relevant for determination of the issue whether the applicant is entitled to get the remuneration as daily rated casual employee in terms of Memorandum No. 9008-F(P) dated September 16, 2011 issued by the Finance Department, Audit Branch, Government of West Bengal. The said Memorandum is applicable to daily rated casual employees and others as enumerated in the same Memorandum dated September 16, 2011. Since the applicant has been working as daily rated casual employee, the respondent no. 2 should have been considered the claim of the applicant in terms of the said *G.O. dated September 16, 2011, but the consideration was* not done in terms of Memorandum dated September 16, 2011. Accordingly, the impugned order communicated under letter dated June 07, 2018 by the respondent no. 2 is set aside.

In view of our above observation, we direct the respondent no. 1, the Director, Directorate of Horticulture, Government of West Bengal to consider the entitlement of the applicant to get remuneration as daily rated casual employee in terms of Memorandum No. 9008-F(P) dated September 16, 2011 and other Memorandums issued from time to time by the Finance
