The above order passed by the Tribunal in OA-904/2008 was challenged before the Hon'ble High Court by filing W.P.S.T. No. 131 of 2014. By passing an order on June 03, 2014, the Hon'ble High Court, Calcutta disposed of W.P.S.T. No. 131 of 2014 without interfering in the order passed by the Tribunal.

With the above factual matrix, Mr. M.N. Having heard both sides, we find that the applicants were given seniority by treating the date of appointment w.e.f. the date when immediate junior in the panel prepared on merit joined in the service without giving them any financial benefit whatsoever. The applicants actually joined in the service on February 23, 2006 while they got benefit of joining in the service on November 11, 1994 and thereby the length of service of each of the applicants was increased by almost 12 years. The respondents may consider the changed dates of appointment of the applicants for giving any kind of service benefit to the applicants except any financial benefit which might have accrued to the applicants for treating their date of appointment w.e.f. November 11, 1994. In the instant application, the applicants have prayed for grant of pay protection and other financial benefits to which they are not entitled in terms of order passed by this Tribunal in OA-904/2008 being
