respondent no. 2 has blatantly violated the direction given by this Bench on October 12, 2018 in OA 645 of 2018. It is pertinent to point out that the respondent no. 2 has added 2 (two) riders of recovery of Rs. 63, 750/- and Rs. 11,92,934/- for the purpose of release of provisional pension in favour of the applicant for a period of 12 (twelve) months, though these riders were conspicuously absent from the direction given by this Bench on October 12, 2018. We would like to give the respondent no. 2 one more opportunity to issue fresh order in compliance with the direction giving by this Bench on October 12, 2018 on cancellation of order dated February 12, 2019.

Mr. S. N. Ray, Learned Counsel, Mr. S. Ghosh, Learned Counsel have jointly prayed for accommodation till Friday for issuance of fresh order by the respondent no. 2 on cancellation or modification of the order already issued by him on February 12, 2019. Accommodation is granted for such purpose till February 15, 2019. The respondent no. 2 is directed to submit fresh order of provisional pension in terms of direction given by this Tribunal on October 12, 2018 on cancellation /modification of order dated February 12, 2019 positively on February 15, 2019 at 12.45 p.m.

On prayer of Learned Counsel for the state respondents accommodation is granted for filing reply. The respondents are directed to file reply positively on
