Hati, learned advocate appearing on behalf of the applicant submits that as the applicant was born on 8<sup>th</sup> December, 1955 and had completed fifty years of age and twenty years of service in 2006, the impugned order passed by the authorities, relying on the Government notification dated 7<sup>th</sup> February, 2014 issued by the Finance Department (Audit Branch), Government of West Bengal amending the rule 75(aaa) and inserting rule 75(aaaa) is not applicable.</p> <p>Mr. S. Ghosh, learned advocate for the State respondent submits that the action of the respondent is just and proper.</p> <p>Heard learned advocates for the parties.</p> <p>Since we find that on the date of notification dated 7<sup>th</sup> February, 2014 issued by the Finance Department (Audit Branch), Government of West Bengal , the applicant had already attained the age of fifty years and had performed more than twenty years of service and thus, right has already accrued in favour of the applicant under rule 75(aaa), the amended rule 75(aaaa) is not applicable. Be it mentioned that a right accrued cannot be divested in the manner it has been done.</p>
