It further appears from the materials on record that the applicant joined as Medical Officer at Deben Mahato (Sadar) Hospita, Purulia on August 16, 2013 after availing 10 days of joining time. The L.P.C. issued in favour of the applicant by the Additional Director of Health Services (Accounts), Government of West Bengal on October 31, 2013 indicates that the applicant received the monthly salary from the office of Director of Health Services, Government of West Bengal till the month of October, 2013. The Bank statement submitted by the applicant by way of Supplementary Application indicates that the applicant has not received the monthly salary in the month of November, 2013. Even the Form 16 issued in favour of the applicant by the Superintendent of Deben Mahato (Sadar) Hospital, Purulia indicates that there is shortfall in salary of 1 (one) month of the applicant during the period of service of the applicant at Deben Mahato (Sadar) Hospital, Purulia. Accordingly, we are of the view that the applicant was not paid monthly salary for the month of November, 2013. It appears from record that the applicant is now working in Calcutta Medical College and Hospital with effect from the month of December 2014 and thereby the Principal of Calcutta Medical College and Hospital is the competent authority of disbursement of arrear salary of</i></p>
