The applicant claims to have resumed duty on December 22, 1990 on the basis of direction given by the Hon'ble High Court, but the order of the Hon'ble High Court has not been produced by the applicant before the Bench. What transpires from the materials on record is that the long absence of the applicant from duty during the period from 1982 to 1990 was regularized by order dated October 08, 2010 in MA-46/2010 arising out of TA-64/2000. We do not find any relevance of order of the Tribunal and subsequent order of regularisation of absence of the applicant from 1982 to 1990 with the prayer of the applicant for interest on arrears of salary. The applicant is directed to file supplementary application annexing copy of Orders/Judgment passed by the Hon'ble High Court on the basis of which the applicant resumes duty on the next date of hearing.
