	(in short, the ROPA Rules, 1981), but also in terms of	
	the subsequent ROPA Rules framed by the Government	
	of West Bengal. The further contention of the applicant	
	is that he got the benefit of higher scale of pay on

	of Memorandum No. 6075-F dated June 21, 1990 and

None appears on behalf of the state respondents Mr. Ghosh. Learned Counsel who except represented the Respondent No. 4, Additional Chief Government Secretary to the of West Bengal, Department of Health & Family Welfare. Mr. Ghosh submits that the Respondent No. 4 has no role to play in either granting or denying pre-revised scale no. 19 to the applicant.

We have heard Mr. Mitra, the Departmental Representative of Respondent No.5, who submits that the Respondent No. 5 has no role to play in either granting or denying pre-revised scale no. 19 to the applicant.

Now the issue for our consideration is whether the applicant is entitled to get pre-revised scale No. 19 at par with the Medical Officer of West Bengal Health Service. There is no dispute that the applicant joined as Medical Officer in the Directorate of Vagrancy in the scale of pay which was applicable to the Medical Officer of West Bengal Health Service in terms of the provisions of the ROPA Rules, 1981. There is nothing on record to deny the contention of the applicant that he was granted the same scale of pay which was granted to the Medical Officer of West Bengal Health Service in terms of the

Admittedly, the applicant was denied the pre-revised
scale no. 19 after completion of 25 years of service even
after fulfillment of the conditions of his serving in scale
no. 18 as contended by Learned Counsel for the

On joint reading of Memorandum dated December 28, 2012 and Memorandum dated April 30, 2013, it appears that the State Government intended to grant benefit of pre-revised Scale No. 19 to the all Medical Officers of West Bengal Health Service on completion of satisfactory service of 25 years, provided they served for 3 years in pre-revised Scale No. 18 on the following two grounds: first, these Medical Officers did not get any promotion to the post having higher scale of pay during last 25 years and secondly, they could not be accommodated within the number of posts (55) indicated

in Memorandum No. 3015-F dated March 13, 2001 for grant of pre-revised Scale No. 19. Since the applicant has all along been treated at par with the Medical Officer of West Bengal Health Service for grant of scale of pay and other financial benefits of service, he cannot be discriminated at the fag end of his career by denying pre-revised Scale No. 19 only on the ground that his service is not State Constituted Service.

On consideration of the object of granting prerevised Scale No. 19 to the Medical Officer of West Bengal Health Service, we are constrained to hold that the applicant has fulfilled all conditions for grant of prerevised Scale No. 19 at par with the Medical Officer of West Bengal Health Service. The promotional avenue was not made available to the applicant even after completion of 25 years of service and he served in prerevised scale no. 18 for 3 years as contended by Learned Counsel for the applicant and as such denial of the benefit of pre-revised scale no. 19 to the applicant at par with the Medical Officer of West Bengal Health Service is arbitrary, discriminatory and violative of Article 14 of the Constitution of India.

In view of our above findings, the impugned order communicated under letter dated April 27, 2015 issued by the Deputy Secretary to the Government of West Bengal, Department of Women & Child Development and

Social Welfare (Annexure 'E' to the original application) is set aside. The Respondent No. 1, Principal Secretary to the Government of West Bengal, Department of Women and Child Development and Social Welfare is directed to re-consider the entitlement of the applicant to get pre-revised scale no. 19 at par with the Medical Officer of West Bengal Health Service in terms of Memorandum No. 10581-F(P) dated December 28, 2012 issued by the Finance Department, Audit Branch, Government of West Bengal by passing a reasoned order after obtaining necessary approval from the Finance Department, Government of West Bengal, if necessary, within a period of 12 (twelve) weeks from the date of communication of the order and take necessary follow-up action within a period of 08 (eight) weeks thereafter.

With the above direction, the original application stands **disposed of.**
