	applicant by passing a reasoned order within specific	

period of time. Accordingly, on August 18, 2006, the Director of Land Records and Surveys and Joint Land Reforms Commissioner, West Bengal passed a reasoned order by recommending the name of the applicant for appointment in regular establishment as Group 'D' employee. Ultimately, on June 22, 2007, the District Land & Land Reforms Officer, Bankura issued the order of appointment in favour of the applicant in a Group 'D' post subject to the condition that the past service rendered by the applicant shall not be taken into consideration under any circumstance. The applicant joined in a Group 'D' post by accepting the condition laid down in the order of appointment and retired from service on March 31, 2016 and thereby he rendered service as a Group 'D' employee for total period of eight (08) years nine (09) months and four (04) days.

With the above factual matrix, Learned Counsel for the applicant submits that the past service rendered by the applicant as Tahashil Mohurrir may be taken into consideration for computation of qualifying service for grant of pension and other retirement benefits. On the other hand, the Departmental Representative of the respondents contends that the past service rendered by the applicant cannot be taken into consideration in terms of the condition incorporated in the order of appointment accepted by the applicant for joining in

Having heard both parties and on consideration of the materials on record, we find that the applicant annexed one certificate of Junior Land Reforms Officer, Kotulpur, Bankura wherefrom it appears that the applicant was engaged as Tahashil Mohurrir under Kotulpur Land Reforms Circle during the period from 1971 to 1984. Admittedly, any employee engaged as Tahashil Mohurrir renders service for a period of four (04) months in a calendar year and as such the service rendered by the applicant as Tahashil Mohurrir is that a seasonal worker, which cannot be construed as temporary service of a government employee. That apart, the service rendered by the applicant as Tahashil Mohurrir during the period from 1971 to 1984 did not continue till the appointment of the applicant as Group 'D' employee on June 22, 2007. Even assuming for argument's sake that the applicant rendered service as a temporary government employee from 1971 to 1984, the said service was disrupted for a period of almost twenty three (23) years before appointment of the applicant as a Group 'D' employee on June 22, 2007, and as such the applicant is not entitled to get benefit of past service rendered by him as Tahashil Mohurrir.

In view of our above findings, we cannot persuade ourselves to give any direction for counting of past
