the Intelligence Department of Police has not cleared the case of the applicant and as such salary of the applicant has been withheld by the impugned order dated August 13, 2019.

With the above factual matrix, Mr. Halder, Learned Counsel for the applicant contends that the interim order may be passed for disbursement of salary pending final decision of the original application, so that the applicant may get monthly salary, particularly when the applicant has already approached the Hon'ble High Court at Calcutta praying for quashing of the criminal proceeding pending against the applicant. He further submits that the criminal case has been started against the applicant in a malafide way and as such the criminal proceeding is liable to quashed in due course.

No notice has yet been served on the state respondents by the applicant and as such we are not in a position to hear the state respondents at this stage. Since the applicant is involved in a criminal case where charge-sheet has already been submitted before the competent Court of Law and since the said criminal proceeding has not yet been quashed by the Hon'ble High Court, we cannot persuade ourselves to
