said respondent and thereby the applicant is being deprived of Rs. 7,053/- p.m. w.e.f. July 01, 2010.

Having heard Learned Counsel representing both parties and on consideration of the representation submitted by the applicant before respondent no. 2 through proper channel on September 27, 2013, we find that the applicant has projected her case before the authority concerned by submitting the said representation. The materials have not been placed before us to decide whether Santi Mondal is junior to the applicant. On consideration of the materials on record, we are of the view that the issue of pay protection of the applicant need to be considered in accordance with law on the basis of the representation submitted by the applicant on September 27, 2013.

In view of our above observation, the respondent no. 2, Director of Health Service, Government of West Bengal is directed to consider the representation submitted by the applicant on September 27, 2013 (page 22 to the original application) in accordance with law within a period of 12 (twelve) weeks from the date of communication of the order and take necessary follow up action, if any, after giving an intimation in this regard to the applicant within a period of 4 (four) weeks thereafter.
