not yet been issued, resulting in delay in consideration of claim of the applicant for compassionate appointment.

Since the husband of the applicant died before completion of 10 years of service without nominating any one for receiving benefits of service, it incumbent upon the respondent no. 3, District Magistrate, Purulia to issue legal heirship certificate of Pranab Mahato since deceased. Accordingly, we direct the respondent no. 3, District Magistrate, Purulia to issue legal heirship certificate of Pranab Mahato since deceased within a period of 12 (twelve) weeks from the date of communication of the order.

The respondent no. 2, Divisional Forest Officer, Kangsabati North Division is directed to ensure release of financial benefits of service of deceased Pranab Mahato in favour of his legar heirs within a period of 12 (twelve) weeks from the date of receiving legal heirship certificate from the District Magistrate, Pululia. The applicant is directed to submit fresh application in prescribed format for compassionate appointment within a period of 4 (four) weeks from the date of release of benefit of service of her deceased husband before the respondent no. 2. If any such application is filed by the applicant for compassionate appointment, the respondent no. 2, Divisional Forest Officer, Kangsabati North Division is directed to consider the said application in accordance
