The contention of the applicant is that he was engaged as part time Water Carrier in the establishment of the Respondent No. 3 and he has been receiving only ₹ 500/- per month in violation of the memorandums issued by the Finance Department, Government of West Bengal.</p> <p>None appears on behalf of the state respondents inspite of service of notice. Having heard Learned Counsel for the applicant and on consideration of the materials on record, we find that the applicant has been engaged as part time Water Carrier/Casual Employee in the establishment of the Respondent No.</p>
