	It appears from the materials on record that one Golam Murtaza died on November 27, 2013 while he was working as Warder at Katwa Sub-Correctional Home in the district of Burdwan. The applicant no. 1 claiming to be the wife of Golam Murtaza submitted application for release of retirement benefits of her deceased husband and for grant of family pension in her favour. The grievance of the applicants is that the retirement benefits and family pension have not been released during last more than 4 years on the ground that the Respondent no. 5, Mina Begum has also submitted her claim for family pension and share of retirement benefits as wife of Golam Murtaza. 	Having heard Learned Counsel representing both parties and on consideration of the facts that the dispute	
	between the claim of applicant no. 1 and the claim of the	
	Respondent no. 5 has not been resolved by the pension	
	sanctioning authority and thereby retirement benefits and	
	order of family pension have not yet been issued. We are	
	informed that the Respondent no. 4, Superintendent,	
	Katwa Sub-Correctional Home is the pension sanctioning	
	authority of the deceased Golam Murtaza.	
	In view of our above findings, the Respondent no. 4,	
	Superintendent, Katwa Sub-Correctional Home is directed	
	to consider the claim of applicant no. 1Mafroja Bibi and	
	the Respondent no. 5 Mina Begum for grant of family	
	pension and other retirement benefits and pass a reasoned	
	order after giving both of them an opportunity of hearing	
	within a period of 12 weeks from the date of	
	communication of the order, so that all retirement benefits	
	of Golam Murtaza may be released and family pension
