Having heard Learned Counsel representing both parties and on consideration of the materials on record, we find that the applicant has previously submitted representation before the Director of Ayurvedic and before the Joint Secretary (Ayush) to the Government of West Bengal, Department of Health & Family Welfare through his Learned Advocate. Since the said representations have not been submitted before the Principal Secretary of the concerned department, the said representation cannot be considered by the Principal Secretary of the concerned department, who is competent to take a decision in this regard.
