It is submitted by Mr. S. Mitra, learned advocate for the applicant that since July, 1966 the applicant had uninterruptedly carrying out the work of casual employee and was made permanent in the post on 18th April, 1996 and had superannuated on 30th June, 2001, the period of uninterrupted service from July, 1966 till 18th April, 1996 may be taken into consideration for payment of pension. In this regard our attention has been drawn to the judgement of the Calcutta High Court passed on 11th November, 2010 in W.P.S.T. No. 184 of 2010 and on 30th April, 2014 in W.P.S.T. No. 31 of 2014.

Mrs. S. Agarwal, learned advocate for the respondents submits that the facts in W.P.S.T. No. 184 of 2010 and W.P.S.T. No. 31 of 2014 are not similar to the facts herein as the applicant has not demonstrated that her husband worked uninterruptedly from 1966 till 1996.

Mr. B. Mitra, the Departmental Representative of the Principal Accountant General, ((A&E), West Bengal supports the stand taken by Mrs. S. Agarwal.

Heard the parties. It is not clear from the copies of documents annexed to this application that the applicant had worked uninterruptedly from July, 1966 till 17th April, 1996. Since this, in our view, is a question of fact,
