State of West Bengal took policy decision of not making any recruitment to the post of Work Assistant due to reduced work load in the Directorate of Public Works (Roads), except appointment to the post of Work Assistant from exempted category to fill up only 30% of the vacant posts. Nothing is on record to indicate that there is scope for promotion from the post of Road Mate to the post of Work Assistant in the Directorate of Public Works (Roads) Government of West Bengal under exempted category at the relevant point of time. Moreover, there is nothing on record to indicate that the applicant was appointed initially in the post of Road Mate from the exempted category. Naturally, the claim of promotion of the applicant from the post of Road Mate to the post of Work Assistant in the Directorate of Public Works (Roads) is rightly turned down by the Chief Engineer, PW (Roads) Directorate, which was communicated to the applicant under letter dated December 31, 2010.

In view of our above observation, the original application stands disposed of.
