Mr. S. Ghosh, learned advocate appearing on behalf of the respondents submits that as the applicant was absent unauthorisedly, it was his duty to apply for regularising the leave. Not having done so, he is not entitled to interest as prayed for.

In reply it is submitted by Mr. Ray that as it is evident from paragraph 5 (c) that after several requests and reminders, the unauthorised absence of 24 days was regularised, the applicant is entitled to the orders as prayed for.

Heard Mr. Ray and Mr. Ghosh. The applicant had superannuated on 31st July, 2011. It appears that after "several requests and reminders" the unauthorised absence of the applicant from 13th February, 2009 to 8th March, 2009, was "ultimately".........."was regularised by the respondent no.2 under his order no. HPH/3" R"-01/2012/400/1(3), dated 18.12.2012 which order was received by the Assistant Chief Medical Officer of Health, Jalpaiguri (Sadar), Jalpaiguri, the respondent no.4 on 07.01.2013."(paragraph 5 (c) of the written reply) It is to be noted that during January, 2013 the applicant was posted at Jalpaiguri. So it is clear from the paragraph 5 (c) of the written reply that there was delay on the part of the respondents in dealing with the issue of unauthorised absence which was regularised after several requests and
