None appears on behalf of the State respondents. We have heard Mrs. Mitra, Learned Counsel for the applicant who submits that the applicant was not given any opportunity of hearing before deduction of excess payment made to the applicant on account of DA and HRA after his joining in Group C post in the establishment of ADSR, Murshidabad.

On consideration of the provisions of West Bengal Services (Appointment, Probation and Absorption of Group C Employees) Rules, 2013, we find that the persons joining in Group C post is entitled to get only basic pay plus grade pay with annual increment of 3% p.a. and medical allowance during the period of probation as per provision of Rule 8 of the said Rules. Since the West Bengal Services (Appointment, Probation and Absorption of Group C Employees) Rules, 2013 was in force at the time of issuance of the appointment letter in favour of the applicant in Group C post on January, 9 2014, the applicant is entitled to get only basic pay plus grade pay with annual increment of 3% p.a. and medical allowance during the period of probation. Since there is no provision for payment of DA and HRA under the said Rules of 2013 in favour of any Group C employee during the period of probation, the applicant has over drawn the amount of DA and HRA immediately after joining in the Group C post in the establishment of ADSR, Murshidabad. Accordingly, the excess payment drawn by the applicant was duly deducted by the authority concerned and the applicant should not have any
